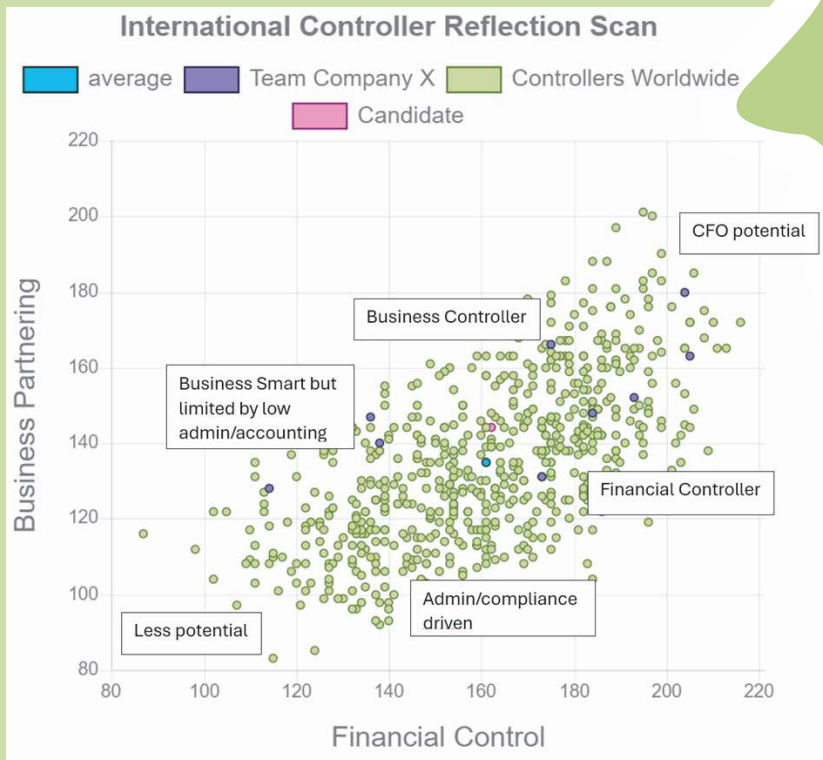

Unique scans

- www.businesscontroller.nu has developed dozens of unique subject-matter scans for Finance professionals.
- Not only for Business Controllers, but also for Controllers and CFOs worldwide.
- Their strength also lies in the ongoing peer comparison on subject-matter situations with other candidates who have already left their test results.
- The database now contains more than 12,000 results. This makes the outcome of the test highly powerful in itself. Its value increases even further when the candidate receives a thorough feedback session in which the results are interpreted within his or her context (relevant education, acquired exposure, and future challenges).

Examples of subject-matter scans

- Talent scans for starters, either short or broader in scope, including digital finance.
- Scans for operational administrative roles.
- Scans focusing purely on accounting / financial control, or on BI Data / Digital Finance.
- Scans that broadly assess strengths, talent and type (e.g. Financial Control versus Business Control). Example visuals: *International Controller Reflection Scan*.
- Scans focusing purely on business partnering / business control.
- CFO scans / in many variations. Example visual: *CFO Scan*.

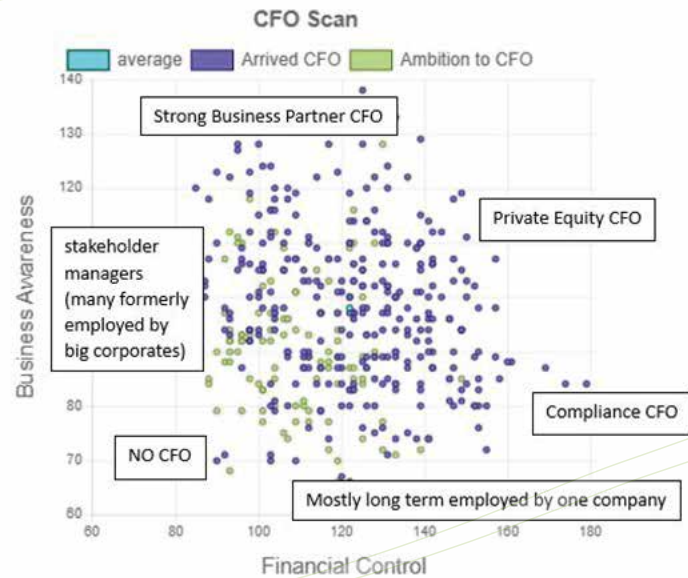
- BusinessController.nu works with both direct clients and business partners.

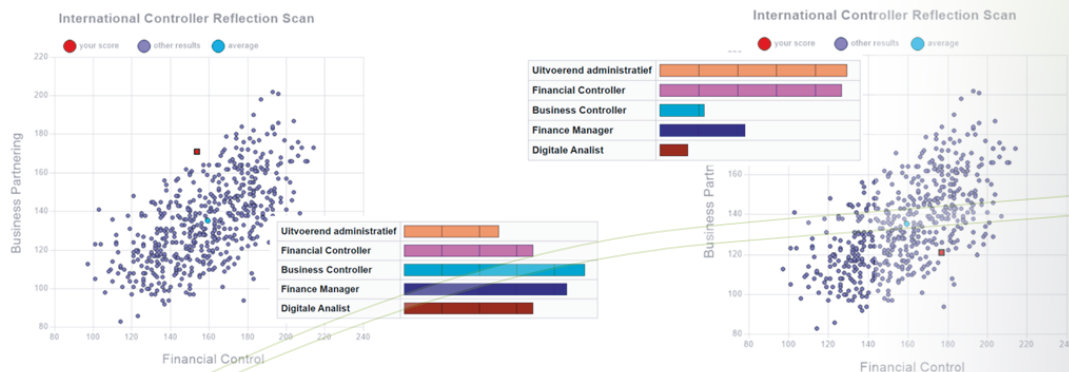
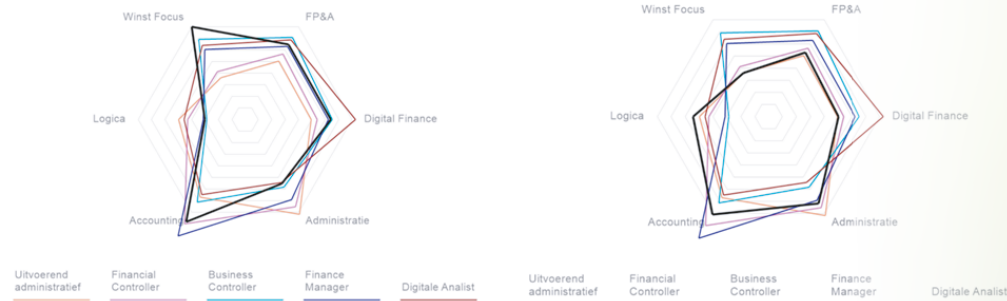
- Paul Kramer studied, lived and worked (as Controller, CFO) for 20 years in various countries. Since 2013 he runs BusinessController.nu.

In addition to thousands of controllers, we also have experience with 1,000+ CFOs. Our database for peer comparison is powerful and one of a kind.

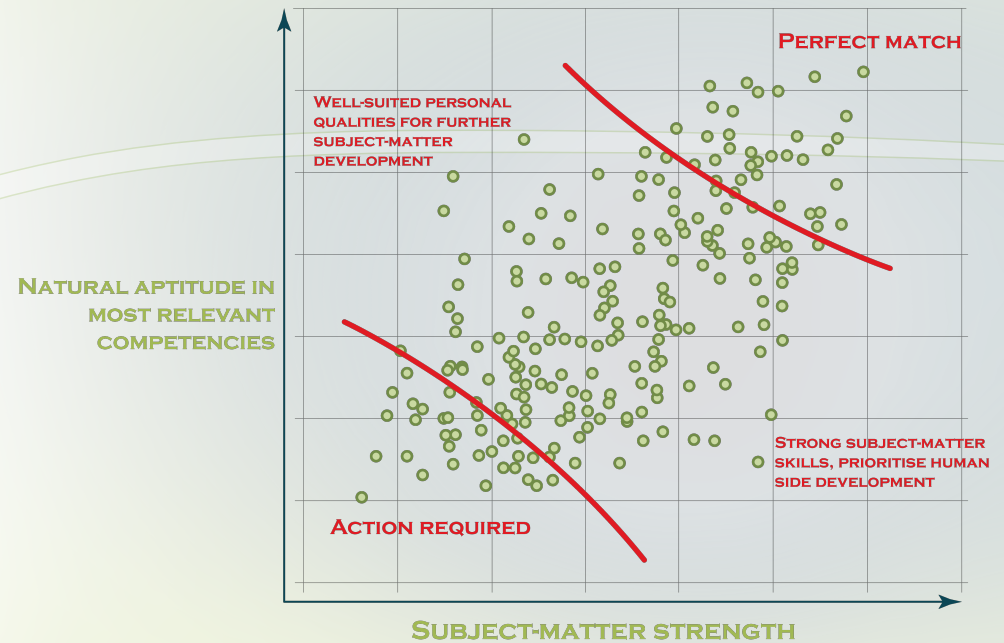
